# General Rules

## CALL FOR STARTUPS

BIOKET invites cutting-edge start-ups to participate in the **BIOKET 2025 Start-up Village!** This is an incredible opportunity for selected start-ups to showcase their innovations at the forefront of the bioeconomy and biomass sectors.

### Opportunities for selected start-ups:

- **Exhibit at the Start-up Village:** Showcase your company during the three days of the BIOKET conference (March 11-13, 2025).
- **Pitch to Investors:** Present your company in a 7-minute pitch in front of specialized investors in the bioeconomy.
- **Both Options:** Combine the exhibition and pitch opportunities for maximum exposure.
- **Brand Visibility:** Have your company's logo featured on our website and communication tools.

### Eligibility criteria:

- **Capital:** Start-up should have a maximum capital of 10M€, and not be a subsidiary of another company.
- **Age:** The company should be no older than 7 years.
- **Sales:** Maximum sales should not exceed 1M€.

### Advantages of the BIOKET Start-up Village:

- **Delegate Pass:** Each selected start-up will receive one (1) full delegate pass for the 3-days event at a price of 350€ excl. VAT (gala dinner not included)
- **Limited Space, High Exposure:** 16 start-ups will be chosen to display at the Start-up Village in the exhibition area.
- **Pitch Sessions:** 24 start-ups will participate in pitch sessions, including the 16 exhibiting start-ups and an additional 8 start-ups.
- **Delegate Pass Benefits:** Access to the conferences, B2B meetings, Innovation Tours, workshops, and all social events (excluding the gala dinner, which is available as an option).

# CALL FOR STARTUPS

Join the forefront of the bioeconomy and biomass innovation scene by applying for the BIOKET 2025 Start-up Village. **Selected start-ups will have the opportunity to pitch in front of leading investors.**

Start-ups accepted for pitches will be given **7 minutes Pitch time.**

**Please note that by submitting your entry, you agree to register and be available for a pitch session anytime during the conference from March 11 to 13, 2025, in Brussels, Belgium.**

## 1. Submission Process & Guidelines

- **Online Portal:** Submit through the designated online submission system via [[CLICK HERE TO ACCESS THE CALL FOR STARTUPS FORM](#)]
- **Deadline:** **Submit by February 7th, 2025, Midnight CET. Late submissions will not be accepted.**
- **Contact Information:** Provide accurate contact details, including main contact name and email; and the start-up name.
- **Format:** All uploaded documents during the submission process must be in PDF format.
- **Language:** All uploaded documents during the submission process should be in English.
- **Content:**
  - **General Information:**
    - **Company Name:** Provide the full legal name of your company.
    - **Main Contact Name:** Provide the name of the primary contact person for your application.
    - **Email Address:** Ensure the email is accurate for official communication.
    - **Phone Number:** Provide a valid phone number for contact purposes.
    - **Mobile Number:** Optional, but recommended for more immediate communication.
    - **Company Address:** Include the full postal address of your company.
    - **Job Title:** State the job title of the main contact person.



# General Rules

## CALL FOR STARTUPS

- **About Your Start-Up:**
  - **Founding Date:** Indicate the official date when your start-up was founded.
  - **Founder(s) Name(s):** List the names of the founder(s) of the start-up.
  - **Turnover:** Provide the most recent annual turnover of your start-up.
  - **Number of Employees:** State the current number of employees in your start-up.
  - **Website:** Provide the URL of your start-up's official website.
  - **Main Activity:** Briefly describe the primary business activity of your start-up.
  - **Investor Pitch:** Indicate whether you wish to participate in an investor pitch to raise funds for your start-up. If "Yes," specify the amount of investment expected (in Euros).
  - **Stand in Start-Up Village:** Indicate whether you would like to have a stand in the start-up village.
- **Project Team: (you can list up to five team members.)**
  - For each team member, provide the following information:
    - **First & Last Name:** Full name of the team member.
    - **Job Title:** The current job title within the start-up.
- **Concept/Innovation/Technology Description:**
  - **Description:** Provide a concise description of your concept, innovation, or technology. The description should not exceed 500 words.
  - **Technology Readiness Level (TRL):** Indicate the TRL of your innovation, selecting from TRL 1 to TRL 10.

## 2. Acceptance

- **Notification:** Start-ups will be notified of acceptance or rejection by **February, 2025**.
- **Presentation:** Accepted start-ups must have at least one team member available for presentation anytime during the conference from March 11 to 13, 2025, in Brussels, Belgium.

### 3. Presentation Requirements

- **Time Allotment:** Prepare to adhere to the 7-minute presentation time allotted.
- **Format:** Presentations must be in PPT format.
- **Language:** Presentations should be in English.
- **Availability:** Be available for presentation at any time during the conference dates from March 11 to 13, 2025 in Brussels, Belgium.

### 4. Ethical Considerations

- **Plagiarism:** Submissions must be free of plagiarism.
- **Conflict of Interest:** Disclose any potential conflicts of interest.

### 5. Conference Registration

- **Fees:** Accepted start-ups must register for the conference and pay the applicable fees. Each start-up member benefit from an exclusive registration price of **350€ VAT excl. (includes full access to the 3 days; gala dinner not included)**
- **Discounts:** Check for any additional discounts or special rates at [bioket.tech](https://bioket.tech)

### 6. Authorization

- **Presentation Sharing:** By submitting your start-up, you authorize BIOKET to share your presentation with all conference participants after the event.
- **Use of Voice and Image:** You also authorize the use of presenters voice and image during the conference for promotional and educational purposes.

**Following these rules will ensure a smooth submission process and enhance the chances of acceptance for your paper at BIOKET 2025. Always refer to the specific call for papers for detailed instructions and requirements.**
